Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. - Our affiliates include companies with a common corporate owner Peach State Bancshares, Inc.; financial companies, such as mortgage bankers, securities broker-dealers, and insurance agents.			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. - Nonaffiliates we share with can include mortgage companies, insurance companies, direct marketing companies, and financial companies.			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. - Our joint marketing partner(s) include mortgage companies, insurance companies, direct marketing companies, and financial companies.
